# THE LIST OF EXISTING USES OF THE TRIBAL WATER RIGHT BLACKFEET TRIBE-MONTANA WATER RIGHTS COMPACT

The Blackfeet Tribe, the United States, and the State of Montana (collectively "the Parties") have entered into a Compact settling the water rights of the Blackfeet Tribe ("Blackfeet Compact"). The Parties have ratified and signed the Compact. Article IV.I.3 of the Blackfeet Compact provides that the Blackfeet Tribal Water Resources Department and the United States will provide the Montana Department of Natural Resources and Conservation with a list of all uses of the Tribal Water Right existing as of 2009. Pursuant to this provision, the Parties have agreed upon a process to finalize and reach agreement on the list of existing uses. The State similarly must provide the Tribe a list of valid state water rights on the Reservation.

The Tribe and the United States have prepared a Preliminary List of the existing uses of the Tribal Water Right and now provide this Public Notice of the Preliminary List to inform you where you may view the Preliminary List and how you may submit questions or comments you may have regarding the Preliminary List.

The purpose of your review of the Preliminary List is to determine if the Preliminary List accurately describes your own existing uses, but also other uses you may want to comment on. For example, has a use been omitted, is the stock pond in the right place, or is the irrigated field the right size. You will then have an opportunity to file a Comment Form if the Preliminary List is inaccurate from your perspective.

The Preliminary List contains information for six different types of water use: Irrigation, Stock water, Storage, Waterbodies, Wells, and Wetlands in each of the four basins on the Reservation:

Basin 40F Milk River; Basin 40T St Mary River; Basin 41L Cut Bank Creek; and Basin 41M Birch Creek, Badger Creek, and Two Medicine River

The Preliminary List contains legal descriptions by Section, Township, and Range of the locations of the uses and allotment numbers associated with the uses, which can be viewed by corresponding maps.

You will have 180 days from the date of the publication of the Public Notice to provide information or comments to the United States and the Tribe. If you believe corrections need to be made to the Preliminary List, you will need to fill out a Comment Form (Attached to this Notice). The Comment Form must be postmarked by <u>March 8, 2020</u> and mailed to the Bureau of Indian Affairs, Branch of Water Resources, Suite 300, 2021 Fourth Avenue North, Billings, Montana, 59101, or provided in person at one of the public meetings or at the Tribal or BIA locations above.

The Forms will be reviewed by the Tribe and the United States to determine whether there is a basis to make adjustments to the Preliminary List. The State will then have 180 days to review the Preliminary List. Any issues relating to the List will be resolved by the Parties and a Final List will be agreed on by the Parties.
