## AMENDED PROCLAMATION

**WHEREAS:** The Blackfeet Tribal Business Council is the duly, constituted, governing body within the exterior boundaries of the Blackfeet Indian Reservation, and

**WHEREAS:** The Blackfeet Tribal Business Council has been organized to represent, develop, protect, and advance the views, interests, and resources of the Blackfeet Indian Reservation, and

**WHEREAS:** The enumerated powers of the Blackfeet Tribal Business Council contact in Article VI, section 1 (g) of the Blackfeet Constitution include management of Tribal Affairs in an acceptable and business-like manner, and

**WHEREAS:** On March 15, 2020, pursuant to Resolution 300-2009, Chairman Timothy Davis issued an Emergency Declaration to begin the engagement of the Blackfeet Tribe's Emergency Plan with all entities and jurisdictions affecting the Blackfeet Indian Reservation, and

**WHEREAS:** On March 16, 2020, the Blackfeet Tribal Business Council adopted Resolution 181-2020 in response to the COVID-19 (Coronavirus) outbreak that posed a threat to the Blackfeet Indian Reservation and reaffirmed the Emergency Declaration by Chairman Timothy Davis of March 15, 2020 and set forth efforts to "flatten the curve" of the COVID-19 outbreak, and

**NOW, THEREFORE THE BLACKFEET TRIBAL BUSINESS COUNCIL THROUGH THEIR EXECUTIVE COMMITTEE, DOES HEREBY SET FORTH THE ORDERS IN THIS AMENDED PROCLAMATION FOR THE BLACKFEET TRIBE OF THE BLACKFEET INDIAN RESERVATION:**

1. The reservation wide curfew shall continue from **10:00 p.m. to 6:00 a.m.** daily.  
1<sup>st</sup> Offense shall be a warning; 2<sup>nd</sup> Offense shall be a citation with a fine.
2. Administrative Leave for Tribal Employees shall continue.

3. All Blackfeet Tribal Offices & Buildings shall remain closed until further notice and employees will not need to do timesheets until further notice. Extensive cleaning is being done at all the Tribal Buildings and employees are directed to not be in the buildings. Only Essential Emergency Personnel are allowed at this time.
4. Alcohol sales on the Blackfeet Reservation shall be 8:00 a.m. to 8:00 p.m. until further notice.
5. All borders and roads accessing Glacier National Park from the Blackfeet Reservation (East Entrance) are hereby closed due to the health and safety of the Blackfeet Tribe until further notice. Glacier National Park is closed at this time by the U.S. Department of Interior.
6. All Tribal Employees who have traveled to a confirmed COVID-19 "hot spot" are required to self-quarantine for 14 days. Also, any Tribal Employees violating the Resolution 181-2020 or this Proclamation shall forfeit their Administrative Leave and will be dealt with administratively.
7. The elderly and those with compromised immune systems/vulnerable are to remain indoors unless they need medical attention or essentials.
8. Wash your hands regularly and please practice good hygiene. If you are sick you are asked to please remain at home.
9. **Stay at Home Order:**
  - i. Stay at home or place of residence. With exceptions as outlined below, all individuals currently living within the Blackfeet Reservation are directed to stay at home or at their place of residence to the greatest extent possible, except as allowed in this Order. As used in this Order, homes or residences include hotels, motels, shared rental units, shelters, and similar facilities.
  - ii. Non-essential social and recreational gatherings of individuals outside of a home or place of residence are prohibited, regardless of size, if a distance of at least six feet between individuals cannot be maintained.
  - iii. All persons may leave their homes or place of residence only for Essential Activities or to operate Essential Businesses and Operations, all as defined below.
  - iv. Individuals whose residences are unsafe or become unsafe, such as victims of domestic violence, are permitted and urged to leave their home and stay at a safe alternative location.
