RESOLUTION

NUMBER: 110-2016

- WHEREAS,** The Blackfeet Tribal Business Council is the duly constituted governing body within the exterior boundaries of the Blackfeet Indian Reservation, and
- WHEREAS,** The Blackfeet Tribal Business Council has been organized to represent, develop, protect and advance the views, interests, education and resources of the Blackfeet Indian Reservation, and
- WHEREAS,** The enumerated powers of The Blackfeet Tribal Business Council contained at Article VI, section 1(g) of the Constitution include the management of tribal affairs in an acceptable and business-like manner, and
- WHEREAS,** The protection of the Badger Two Medicine is paramount to the Blackfeet Tribe in regards to its enduring presence and lasting relationship with the areas of cultural resources, flora & fauna, places and all traditional and future uses, and
- WHEREAS,** The Blackfeet Tribal Business Council believes that the Badger Two Medicine Committee needs to be activated with new members, and
- WHEREAS,** At the direction of the Blackfeet Tribal Business Council, the Badger Two Medicine Committee addresses past and current issues from historical use to the new Lewis & Clark National Forest, Forest Plan, conservation, education, ecology, recreation and management, and
- WHEREAS,** The Blackfeet Tribal Business Council shall receive recommendations from the Badger Two Medicine Committee on various issues central to the Traditional Cultural District of the Badger Two Medicine, and
- WHEREAS,** The Blackfeet Tribal Business Council shall appoint the twelve (12) members of the Badger Two Medicine Committee for terms of four (4) years with any vacancies to be filled by the BTBC, now

THEREFORE BE IT RESOLVED AS FOLLOWS:

- 1.) That the Blackfeet Tribal Business Council hereby reaffirms the twelve (12) member Badger Two Medicine Committee, which shall make recommendations to the Blackfeet Tribal Business Council on interests and concerns associated from a traditional perspective on current and future uses, ecology, conservation, education, recreation and management of the Badger Two Medicine.
- 2.) That the Blackfeet Tribal Business Council shall appoint twelve (12) members to the Badger Two Medicine Committee for terms of four (4) years with any vacancies to be filled by the Blackfeet Tribal Business Council.
- 3.) That the Badger Two Medicine Committee shall be involved in the protection of the Badger Two Medicine in regards to the current recommendations of the Secretary of Agriculture and Secretary of the Interior to cancel all Oil & Gas leases in the Traditional Cultural District of the Badger Two Medicine.
- 4.) That all press releases from the Badger Two Medicine Committee shall be approved by the Chairman of the Blackfeet Tribal Business Council.
- 5.) The Chairman and Secretary are authorized to sign this Resolution on behalf of the Blackfeet Tribal Business Council.
