## RESOLUTION

### **Approving CARES Act Funds for the Solid Waste Program in Response to the COVID-19 Pandemic**

Resolution No. 286-2020

**WHEREAS,** The Blackfeet Tribal Business Council is the duly constituted governing body within the exterior boundaries of the Blackfeet Indian Nation pursuant to Section 16 of Act of June 18, 1934 and Amendments thereof, and

**WHEREAS,** The Blackfeet Tribal Business Council has been organized to represent, develop, protect and advance the views, interests, and resources education and resources of the Blackfeet Indian Reservation, and

**WHEREAS,** The Blackfeet Tribal Business Council is empowered, pursuant to Article VI- Powers of the Council, Section 1(e) to manage all economic affairs and enterprises of the Blackfeet Reservation; and, Section 1(g) to manage tribal affairs in an acceptable and businesslike manner and in accordance with the administrative plan called the Plan of Operations; and, Section 1(k) to promulgate ordinances for the purposes of safeguarding the peace and safety of residents of the Blackfeet Indian Reservation, and

**WHEREAS,** The Blackfeet Tribal Business Council passed the "*Blackfeet Tribe COVID-19 Ordinance*" No. 121 and *Resolution No. 2020-181 "Reaffirming the Declaration Addressing the COVID-19 Outbreak for the Blackfeet Reservation"* and including the "*Stay at Home Order*" (E2020-146), and "*Traffic Restriction Order*" (E2020-148) to limit the risk of infection from the global pandemic outbreak of COVID-19 to members and residents of the Blackfeet Reservation, and

**WHEREAS,** The Blackfeet Solid Waste Program has been designated a Tier I Program based upon the hazardous work duties for the clean-up of the Blackfeet Reservation during the COVID-19 Pandemic, of which involves the disposal of pathological refuse for the Blackfeet Reservation including residential and business areas to which the sanitation workers and public are currently exposed to such refuse without proper protection, and

**WHEREAS,** Based upon the need to keep the Blackfeet Reservation in a clean manner and to prevent the spread of COVID-19 and potential infection from the Coronavirus, the Blackfeet Solid Waste Program is in need of equipment and supplies for such requirement, and

**WHEREAS,** The Blackfeet Tribal Business Council desires to set aside funds for the Blackfeet Solid Waste Program to include vehicles, trash receptacles, PPE, and any other equipment or supplies needed based upon a budget to be submitted by the Director as soon as possible, estimated around 1.2 million to 2 million in funds, now

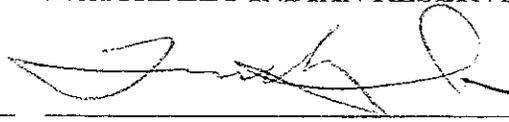
**THEREFORE, BE IT RESOLVED AS FOLLOWS:**

1. Approval of 1.2 to 2 Million for Solid Waste Program out of CARES Act Funds. That the Blackfeet Tribal Business Council hereby approves 1.2 to 2 Million to the Solid Waste Program for the identified needs in this Resolution out of the Treasury CARES Act Funding for the Blackfeet Tribe.
2. Public Advertisement. The Public Relations Specialist is hereby directed to make notice effective immediately of this Resolution to the Public in all local media.
3. The Chairman or the Vice-Chairman in the Chairman's absence and the Secretary of the Blackfeet Tribal Business Council are hereby authorized to sign this Resolution and any other documents to effectuate the purposes of this Resolution.

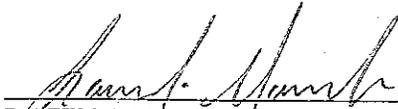
